CULTUS LAKE PARK FEES AND FINES BYLAW NO. 1076, 2016 AMENDMENT BYLAW, BYLAW NO. 1122, 2018

A Bylaw to amend The Cultus Lake Park Fees and Fines Bylaw.

The Board for Cultus Lake Park did enact a bylaw cited as "*Cultus Lake Park Fees and Fines Bylaw No. 1076, 2016*".

The Board for Cultus Lake Park deems it advisable to amend said bylaw;

The Board for Cultus Lake Park, in open meeting assembled, enacts as follows:

1. TITLE

This Bylaw may be cited for all purposes as "The Cultus Lake Park Fees and Fines Bylaw No. 1076, 2016 Amendment Bylaw No. 1122, 2018"

2. AMENDMENTS

- 2.1 In Schedule 6 – Parking – Part 1, remove the wording "If the violation penalty is paid within seven (7) of the date of violation, the said fine shall be reduced by 50%"
- 2.2 In Schedule 6 – Parking – Part 1, remove the wording "Fees associated with the towing of a vehicle must be paid prior to the release of vehicle."
- 2.3 In Schedule 6 – Parking – Part 1, add Section:
1.11 Vehicles parked on Cultus Lake Park property without displaying a valid parking permit.....\$50.00
- 2.4 In Schedule 6 – Parking – Part 1, add Section:
1.12 The use of counterfeit or expired permits.....\$50.00
- 2.5 In Schedule 6 – Parking – Part 2 – Parking Rates, remove Six Month Pass and One Year Pass.
- 2.6 In Schedule 6 – Parking – Part 2 – Parking Rates, replace Daily Rate with:
Daily Rate, May 1 – September 30.....\$12.00
and;
Daily Rate, October 1 – April 30.....\$10.00
- 2.7 In Schedule 6 – Parking add: Part 3 – Fees.
- 2.8 In Schedule 6 – Parking – Part 3 – Fees, add:
Removal of Vehicle Immobilization Device.....\$100.00
