## (10) The *Community Association* raised the following questions to the Board:

C. Rogozinski, representative of the Community Association, noted that in her opinion, the Special Regular Meeting Agenda for December 20, 2023, was not posted in the typical formats similar to other Regular Meetings. She inquired into why a residential leaseholder was able to transfer their boat lift with the sale of their residence at the Special Regular Meeting of December 20, 2023, when residents are currently unable to transfer buoys. She inquired into why the 65 Short-term Rental permit holders are able to transfer their permit with the sale of their residence instead of moving to an individual on the waitlist.

Staff explained that the Special Regular Meeting Agenda for December 20, 2023, was posted as per usual process as set out in the Board Procedures Bylaw.

The Board noted that there was precedence set with a transfer of a boat lift prior to this request, allowing this type of transfer to be permitted. The Board noted that potential changes in the Commercial Foreshore Lease may result in the Board adjusting process with future requests related to transferring buoys and boat lifts.

The Board noted that the decision to allow Short-term Rental permit holders to transfer their permit with the sale of their residence was a result of the review of potential legalities and risk associated with the changes in policy and bylaw.
