Committee members reviewed the listing and asked if the category the RFP was listed under, Multiple Unit Dwelling Construction Services, incorporates the consulting aspect? Staff confirmed that the BC Bid site does not have a category that accurately defines what we are looking for.

Committee members noted that the role of the committee and the role of the Board with respect to the RFP, that staff will manage communications from any proponents during this stage of the RFP. Committee members noted that at the June 3, 2025, In-Person Proponent's Mandatory Pre-Bid and Site Meeting, that staff will manage this meeting. Staff noted they would take the questions from proponents and post the responses publicly once completed.

The Chair noted that the development would be built in stages spanning a long-term period and it would be determined which of the highest priority items could be included in the first stages of development based on needs and costs. Staff noted that proponents were not restricted to a single submission.

Committee members asked if there was a vision from the Board with respect to the committee's role beyond the selection of the proponent to continue through the development process. The Chair noted there has not been any discussion on the topic currently.

1. Where would development permits be issue from?

Permits would be issued from the Fraser Valley Regional District. Plan Cultus, Bylaw Number 1080, 2016, Section 3.8 accommodates for the redevelopment of the existing commercial area.

2. Could you provide the status of the sewer upgrades?

3. How are the existing leases structured?

Cultus Lake Park has 487 residential homes and leaseholders lease their properties for a 21-year term and renews under the same terms and conditions under Cultus Lake Park Building Site Lease. The Cultus Lake Park Act empowers the Board to manage, maintain and improve Cultus Lake Park and the Act further specifically

empowers the Board to lease building sites within Cultus Lake Park for private or public use.

4. Who manages the water system in Cultus Lake Park?

5. Will the public works yard building be moved or relocated?

Yes, there are options to move or relocate the public works yard. The cost of this should be covered by the consultant.
