(11) COMMUNITY ASSOCIATION

Cultus Lake Community Association noted there has been an increase in e-bike and e-scooter usage along the waterfront path. They noted that they are concerned that it will only be a matter of time before someone gets hurt, and inquired if there is there anything that can be done to prevent this from occurring?

Chair Dzaman noted that there is an increase in communication with e-scooters and e-bikes, especially along the waterfront path. He noted that the Board has been gathering data from Cultus Lake Bylaw Enforcement as well as receipt of community reports and interactions. The Board is looking at precedence set by other municipalities regarding this matter. Chair Dzaman noted that the Board can govern the park via Bylaws on e-scooters and e-bikes.

Chair Dzaman would like to request parents of children who own e-bikes, or e-vehicles, to please have a conversation with their kids about the safety around e-vehicles.

(12) PUBLIC QUESTION PERIOD

Laurel Shears, resident, inquired about events in the park and what information gets sent out about smoking limitations in the park? She noted that we do not have a no smoking sign on the west side.

Staff noted that to the event organizers that have been organizing this event for several years, when they submit their event application, and staff review it they do receive an approval letter that states they do need to comply with the park bylaws. Staff noted that we had some concerns with respect to smoking and drinking in the park with other participants of those groups, and we have been able to seek compliance.

Laurel Shears, resident, also inquired as to when the Community Hall repairs would be completed as we approach the rainy season.

Staff noted that we have received five (5) quotes for repairs/restoration. Staff noted that we won't be making a claim through our insurance as the deductible is too high. Staff further noted that we are currently working with ICBC to get approval of one of those five (5) quotes. Once ICBC provides approval we are hoping to have it completed in the Fall.

Steve Marks, owner of Cultus Lake Marina, wished to bring to the Boards attention regarding dust control in parking Lot C. He noted that he had requested three (3) dust control applications; one in June, July & August. He noted that the cost is roughly over \$1,000 per one application at Cultus Lake Marina. He noted that to date there has only been one dust control application

applied. He noted that he would like to propose a solution, and noted he has support from all four of his bordering neighbors in this request. He then read the support letters for the neighbors and noted they will be submitted to the Board. He noted for the Board's attention from the National Institute of Occupational Safety regarding silica and its dust the health effects and the exposure could cause silicosis. He noted that it concerns staff and elderly in the area. As an investment in the community in which he lives and works, he pledges to cover the balance of the cost for paving Lot C. He further noted that all lots in the park are paved currently.

Commissioner Jartved commented that it is a very generous offer. She referenced the dust from Lot A, she noted that it would be great to have the lot paved with the gravel pit and Main Beach and can become very dusty. If paved she noted the water that runs off the lot will run directly into the lake, which leads to concerns about the health of our lake, which would need to be addressed. She further noted that our new Green Shores project at the foot bridge was designed to help filter the water that comes off the road. The health of the lake needs to be considered as well before we decide whether we pave the lot or not is to consider the future health of the lake.

Steve Marks, owner of Cultus Lake Marina, noted that with respect to a separator where when you have a lot of water it funnels and/or into a storm drain. He noted that health is more important, and projected costs are approximately \$15 to \$20 thousand dollars, cost prohibited.

Chair Dzaman noted that there are many things to consider.

Brad Shears, resident, inquired about what is happening with the benthic mats in Sweltzer Creek.

Staff noted we lost several mats, and we haven't dedicated any further budgeting to that project. The last count we lost fifteen mats, due to damage caused by weather and storms. It was noted by staff that the original twelve mats were purchased by the twelve homes surrounding Sweltzer Creek.

Brent Shirley, resident, inquired about the Village Center Development and the RFP response(s). He further inquired about the sewer and asked if the streets are connected.

Chair Dzaman noted that there is an RFP with four proponents interested at this time, however t currently there is no information to share as the deadline for submissions is the end of September. He noted that we look forward to seeing some things that align with what the park is looking for. Chair Dzaman noted the sewer is working and those interested can refer to the Fraser Valley Regional Districts website for more information.

Joe Lamb, Chief Administrative Officer, confirmed that it is fully operational and has been operating since March 15th with a 6-month window of monitoring flows, bacteria growth and so on. He further confirmed that the treed streets are connected.

Committee members reviewed the letter of request from Lakeshore Drive residents and noted that the area was originally planted with native species plants but has since become overgrown with invasive plants and blackberry bushes. Staff noted that in order for the request for work to move forward, financial resources will need to be appropriated, and an application made for a work permit that will also need to be approved by the Department of Fisheries and Oceans and an Environmentalist.

Joe Lamb, Chief Administrative Officer, introduced the new Landscape/Gardener, Baljinder Singh, to the committee members. Staff confirmed he will report to the Public Works Supervisor for daily tasks and to the Manager of Park Operations for special assignments.

(5) NEW BUSINESS

(a) CLASS Correspondence for Discussion

- Purple Loosestrife
- Car or house washing recommendations to share to residents
- Cultus Lake Park Tree Registry

Committee members noted they have spoken with members of Cultus Lake Stewardship Society (CLASS) to discuss a plan for the entire lake area. Committee members also noted they will contact the Fraser Valley Invasives Species Society (FVISS) to determine the best course of action for removing loosestrife. Staff asked the committee members to notify them when they locate loosestrife within the park, and they will take action to remove it.

Committee members noted they have put posters on the community boards with respect to car washing as an educational awareness campaign and will ask the Cultus Lake Community Association to send out to their subscribers. Committee members also noted they could invite Dr. Dan Selbie to a public community event to provide further education on the health of the lake.

Committee members discussed the various reasons to consider having a Tree Registry within the park. Joe Lamb, Chief Administrative Officer, noted that staff could review the Committee Terms of Reference for next year with respect to education regarding trees and plants within the park, and that this program would require a request from CLASS to the Board for funding.

(b) **Volunteer Roles**

- Clarity on areas and planning for a weeding Board Committee System Policy

Joe Lamb, Chief Administrative Officer, noted that no one other than park staff should be weeding in the park, however, if committee members wanted to organize a volunteer day, they would need to send the request to the Manager of Park Operations for approval. He also noted that if committee members wanted to establish adoptable areas, they would require approval from the Board and CUPE Local 458 Representatives.

(c) **Invasives**

- Blackberry Spray in the Fall

Joe Lamb, Chief Administrative Officer, noted that work for weed control will be done in the fall in Parking Lot B. He further noted that the Manager of Park Operations will meet with committee members at the south section for their input.

(d) **Mowing**

Committee members discussed different mowing heights for grass areas within the park. Committee members noted they could ask members of CLASS to invite the organizer of the Climate Fair for a delegation with the Board to discuss the benefits to wildlife in leaving the grass at higher lengths and planting clover in areas. Joe Lamb, Chief Administrative Officer, noted that mowing at different heights would require changing the mower set-ups, which would pose a challenge.

Committee members also noted they could ask members of CLASS to invite Mike Flannigan to discuss fire safety at a delegation with the Board in the fall.

Subject: Supporting the work of CLASS and the Economic Valuation Study

Hello, Cultus Lake Park Board Commissioners

Since 2007, the Cultus Lake Stewardship Society (CLASS) has been protecting this gift of the lake and surrounding watershed, and we want to show the economic value that a healthy lake brings to the area.

We have initiated a research project in partnership with UBC Okanagan, Dr. John Janmaat and Masters Student Leonie Steigenberger. In 2026, starting in May thru August, they will conduct a visitor survey based on the Travel Cost and Contingent Behaviour approaches. A Contingent Behaviour survey is *Contingent valuation which involves directly asking people, in a survey, how much they would be willing to pay for a specific environmental service.*

Deliverables:

1. Ongoing interactions between CLASS and Janmaat/Steigenberger to:
 - a. Refine aspects of research to best meet needs of CLASS,
 - b. Open the 'black box' that research can become if a regular exchange is not part of the project.
2. A visitor survey based on the Travel Cost and Contingent Behavior approaches.
 - a. A travel cost survey provides a dollar value representing the enjoyment current visitors receive.
 - b. A contingent behavior survey provides an indication of how visitor numbers and behaviors may change in response to a deterioration in the health of the Cultus Lake system.
 - c. Combined, provide a dollar value representing the decrease in enjoyment visitors expect to receive if the health of the Cultus Lake system deteriorates.
 - d. The survey can be adapted and used again at a future date to explore how things have changed.
3. A report and presentation for CLASS to use in their communications and efforts related to protecting the health of Cultus Lake.
4. Several presentations by Steigenberger and/or Janmaat over the duration of and after the conclusion of the project, to support the work of CLASS and/or explain how the research results can be used to inform policy.
5. A UBC Okanagan master's thesis and a student with a master's degree.
6. CLASS would be responsible for reporting back to the Commissioners on a regular basis on progress if desired.
7. Include Soowahlie First Nation and Ts'elxwéyeqw Tribe Management Limited [TTML] with updates of the project.

There will be 2 semesters in 2026 that we will need some help funding. Some of the costs are incurred by UBC and there is matching funding from MITACS (<https://www.mitacs.ca/>), a nonprofit that co-invests in research-based internship programs. CLASS has committed \$7,500 for 2025 with help from the Park Board commissioners.

We'd like to ask for your support of up to \$27,000 towards this project in 2026 for the masters student and an intern. This covers the CLASS portion of a reasonable salary, accommodation, food, travel costs and tablets.

Attached is a support letter from Dr. Dan Selbie, Fisheries and Oceans Canada providing some background on the health of the lake.

You are a significant stakeholder and know the value that a healthy lake has to visitors, residents and business owners. We look forward to hearing back from you on your thoughts and if you have any questions, please feel free to contact me or Ernie Vance.

Dear Selection Committee,

I am writing in full support of the Cultus Lake Stewardship Society (CLASS) application seeking 2025 HCTF Capacity Grant funds to quantify the environmental/ecological services that Cultus Lake and its watershed provide to Society. The proponents are seeking matching funding to a current MITACS application, permitting a thorough analysis of the system's contribution to regional wealth and well-being, led by an expert in the field, [Dr. John Janmaat of UBC Okanagan](#), who ties his roots to the local community in Chilliwack. This project is an crucial thrust of multi-lateral community, government, and Indigenous-led engagements and actions to preserve the ecological integrity of Cultus Lake, and address known stressors on water quality.

Monetizing ecological services is a key approach to supporting Society in effective valuation of the environment, which is commonly treated as an externality in policy and budgetary decision-making. Doing so leads to explicit environmental consideration and mitigation more likely to be commensurate with the true value of the ecological benefits derived by Society. A preliminary estimate, predicated upon historical road traffic of 2-3 million people visiting the lake, yielded annual contributions of 10's to 100's of millions of dollars (2018), and expert recommendation that detailed estimates be derived to support environmental stewardship (Janmaat & Cebry 2018; i.e. this proposal).

I have had the distinct pleasure of working hand in hand with CLASS, as a primary science advisor for over 16 years, a relationship that has held a razor sharp focus on maintaining the ecological integrity of Cultus Lake, BC, through its various insults (i.e. excess nutrient inputs, climate warming, invasive species), and to sustain its diverse array of ecosystem services (e.g. ecological, economic, cultural). CLASS-DFO-SFU partnered monitoring and research revealed a complex habitat stressor problem (i.e. eutrophication x climate change; [Putt et al. 2019](#)), that imperils fish species at risk, the Cultus Sockeye Salmon (COSEWIC, Endangered; SARA, Under listing consideration; [Selbie et al. 2022](#)) and the Cultus Pygmy Sculpin (*Cottus aleuticus*, Cultus population; COSEWIC, Endangered; SARA, Threatened, Schedule 1; [Loudon et al. 2022](#)), by stimulating excess algal production, seasonal hypoxia in deepwater critical habitats, and internal loading of nutrients and contaminants from the sediments. Through the many twists of this complex environmental science journey, CLASS tirelessly found resourcing for graduate students and supplies, supported sampling, and advocated on behalf of lake health, disseminating knowledge to the community and politicians alike.

CLASS has been a steadfast supporter of science-first approaches to identifying and resolving these problems, and the science is clear: critical near-term interventions are needed to sustain the

Cultus Lake ecosystem from runaway eutrophication, and almost certain degradation, if not significant losses to societal benefits.

Such a complex problem requires an equally intricate habitat management context (i.e. watershed to airshed nutrient abatement, intermediate deepwater lake oxygenation), which touches many jurisdictions, but it is generally believed to be resolvable. Given strong and deep societal valuations of Cultus Lake (Robinson 2012; Janmaat and Cebry 2018), and that every value ascribed to the lake (e.g. recreation quality, foreshore property values, regional economy) is in some way tied to the preservation of water quality in the system, there is unique and strong Indigenous, societal, and inter-governmental alignment on the necessary pathway forward. As demonstrated through their application, CLASS continues to lead in this very important effort.

To realize this sustainable future, Cultus must be valued for what it is, but currently is not, the “Gem of the Fraser Valley” as it is called on the Fraser Valley Regional District website. To truly do so requires communities, elected officials, and Society writ large to be able to value what the lake provides, in a ‘currency’ that is directly comparable to other values, considered in estimations of

risk, and supportive of weighing expensive investments on implementing actions that sustain lake health (i.e. lake oxygenation, reducing agricultural emissions to atmosphere) for all values. Conservation actions at Cultus Lake are at a critical juncture to save species at risk, and a broader set of societal values are in jeopardy as water quality declines. The issue is exceptionally well-informed scientifically, with necessary and tangible conservation actions required and published, and an active stewardship group seeking to take the next steps.

The benefits of investing in this project scale broadly. A detailed ecological services valuation of the lake and its watershed is critically-timed now to properly inform considerations of risk, decisions to invest in stressor mitigation, and collective action on watershed to regional airshed nutrient pollution, which will be essential for Cultus Lake and the myriad other aquatic ecosystems of the BC Lower Mainland and Fraser Valley to weather the intense predicted thermal and hydrological effects of climate change. I sincerely hope you will see the community stimulus potential in a demonstrably effectual proponent, and the means to facilitate substantial resolution of a critical and complex habitat management concern in British Columbia.

I'm writing this letter on behalf of our Paddling Club's need to add 1 hour to our parking time on Saturdays during the paddling season.

Our canoe club is growing through some growing pains as we register more members and develop more teams and need more time slots for paddling our big boats - mainly on Saturday mornings.

Currently members' parking passes allow them to park until 10am on weekends, and parking space is limited in the mornings, even when many members carpool.

In order to have 3 teams paddle our big boats on Saturday mornings, we need to add time slots. For example, hosting practises at 730-830am; 845-945am; 10-11am (aim of getting off the water just before 11am).

We would like to submit a request that our parking passes go until 11am on Saturdays so we have the capacity for members to park and paddle.

I am aware this may not be possible to do by October, but we would like to do it by April. We do need to know sooner than later so that teams can plan for and feel hopeful going through the winter and next spring.

NOTE: To make it easier for the Parks Board to approve this, if a potential concern is 1 hour lost parking income for 1 day per week over maybe 2 main summer months, an option could be for us to supplement some of this pay. Another option, since we only need it for about 20-30 paddlers (from 10-11am), that the computer / ticketing system for license plates is customizable and only those team paddlers log in for those hours. These are just a couple preliminary thoughts.

DISCUSSION:

Staff received an email from Carly Brkich, Destination Marketing Manager, Chilliwack Tourism on September 8, 2025. The email received outlines Chilliwack Tourism's Holly Jolly Chilliwack campaign plans, and the idea of installing 3D photo displays at key locations throughout the community, with Main Beach in mind during the holiday season. Staff have requested more information with respect to a timeline for the display set up during the holiday season.

The concept envisioned a layered, interactive display that invites guests to step between the elements to snap a festive holiday photo. The goal is to create a Holly Jolly-specific touchpoint amongst the lights at the lake, while also encouraging visitors to generate and share content that highlights their experience.

Presenting a vintage ornament design for Cultus with a display that would be built from durable aluminum, making it weather-resistant and sturdy enough to stay secure in a public space at Main Beach.

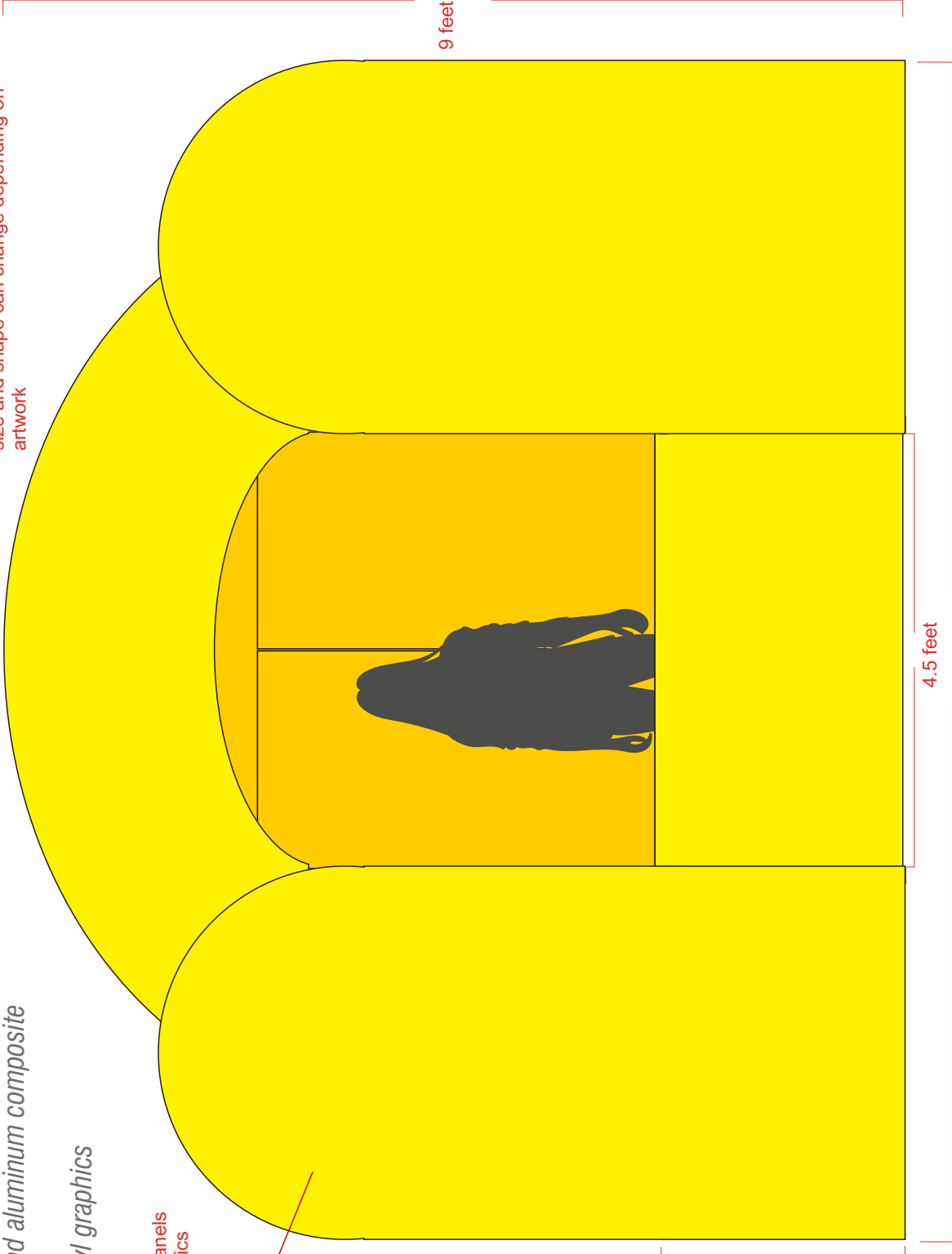

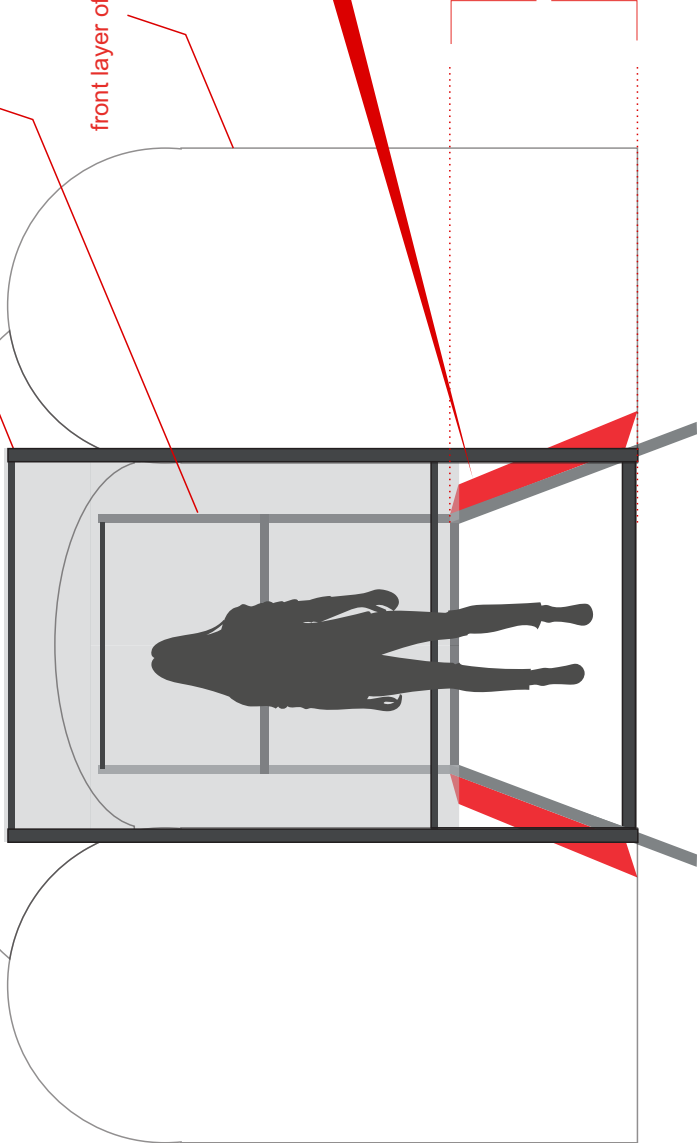

SUBJECT: Understanding Cyanobacteria Bloom

PURPOSE:

The purpose of the report is to provide the Board with information on Cyanobacteria Bloom.

RECOMMENDATION:

***THAT** the Cultus Lake Park Board receive the Understanding Cyanobacteria Bloom report for information; and*

***THAT** the Cultus Lake Park Board considers funding during the 2026 budget discussion to support options to reduce both the risk and growth of Cyanobacteria Bloom.*

DISCUSSION:

The article on Understanding Cyanobacteria Blooms: A Community Concern submitted by Cultus Lake Stewardship. The article outlines serious concerns after several dogs became ill or died from suspected contact with the water on the Nicola Lake related to cyanobacteria blooms, often called "blue-green algae", a notorious symptom of eutrophication.

The article notes, conditions like warmer water and high nutrient levels can cause them to multiply rapidly, forming harmful blooms. It is crucial to understand that not all cyanobacteria are toxic, and even those that can produce toxins do not always do so.

The article speaks to identifying the blooms and can produce cyanotoxins, which pose risks to people, pets, livestock, and wildlife. Exposure to these toxins can lead to a range of symptoms, from skin irritation and stomach upset to more severe illnesses like liver or kidney damage, and in rare cases, even death. Children and pets are especially vulnerable because they are more likely to accidentally swallow affected water.





Understanding Cyanobacteria Blooms: A Community Concern

You probably heard that a dense algal bloom on Nicola Lake in the summer raised serious concerns after several dogs became ill or died from suspected contact with the water. This tragic event highlights a growing issue:



cyanobacteria blooms, often called "blue-green algae", a notorious symptom of eutrophication, are becoming more frequent globally. While they are a natural part of our aquatic ecosystems, certain conditions like warmer water and high nutrient levels can cause them to multiply rapidly, forming harmful blooms. It's crucial to understand that not all cyanobacteria are toxic, and even those that can produce toxins don't always do so. However, for safety, any suspected cyanobacteria bloom should be considered potentially toxic and avoided.

What Are the Risks and How Can You Spot a Bloom?

Despite their name, blue-green algae are actually photosynthetic bacteria. When they bloom, they can produce cyanotoxins, which pose risks to people, pets, livestock, and wildlife. Exposure to these toxins can lead to a range of symptoms, from skin irritation and stomach upset to more severe illnesses like liver or kidney damage, and in rare cases, even death. Children and pets are especially vulnerable because they are more likely to accidentally swallow affected water. Beyond health risks, these blooms can also harm aquatic life by depleting oxygen and blocking sunlight. Cyanobacteria blooms often have a distinct appearance, resembling pea soup, spilled paint, or surface scum, and may have an earthy or musty smell. If you see something like this, it's best to stay clear.

What Causes These Blooms and What Can We Do?

Harmful cyanobacteria blooms thrive under specific conditions. High nutrient levels from sources like agricultural runoff, wastewater, and urban development

are a major factor. Warmer water temperatures, intensified by climate change, also favor cyanobacteria, allowing them to outcompete other aquatic organisms. Additionally, stable water conditions with low wind and periods of drought followed by heavy rain can contribute to bloom formation. These environmental changes create a "perfect storm" for cyanobacteria to flourish.

As a community, we can take steps to reduce both the risk and severity of these blooms. If you suspect a cyanobacteria bloom, report it to your local health authority and avoid contact with the water. You can also submit your observations to Algae Watch BC, a citizen science program that helps experts track and understand these blooms. On an individual level, we can help by maintaining healthy riparian areas (the land along waterways), reducing fertilizer use, properly maintaining septic systems, and using phosphate-free products. By working together to manage nutrient inputs and understand the conditions that lead to these blooms, we can help protect the health of our lakes for everyone to enjoy.

Monitoring

Beach operators are responsible for monitoring beach water quality during the swimming season. This includes the routine collection and testing of water samples for E. coli (a fecal indicator). Cultus Lake Park Board (info@cultuslake.bc.ca) samples from the Main Beach at Cultus Lake weekly, and the BC Park operators Sea to Sky (cultuslake@seatoskyparks.com) monitors weekly at three of their beach locations at the lake. Beach water quality sampling is voluntary and not required by legislation. Fraser Health recommends that beach owners begin beach water sampling approximately four to five weeks prior to the beach being

used for swimming etc., as this will help create a Geometric Mean, which is the main way that the E.coli counts are reported to the public. This would normally mean that some beaches should be sampled as early as the end of April, while others would not need to begin sampling until the beginning of June. Most beaches should be sampled up to and including the first week or two of September, as after this point very few people are using the beach for swimming etc.
