LEASE INFORMATION AND PAYMENT

Each resident has a lease here at the Park and it includes payment for fire protection, garbage and recycling, insurance, streetlights, foreshore improvements, etc.

Cultus Lake Park Building Site Lease payments are DUE each year on MARCH 15.

PAYMENT:

- In person at the Park Office (4165 Columbia Valley Highway)
 - Mailing a cheque “Cultus Lake Park Board”
 - Telephone or online banking:
 - Go to your financial institution’s online banking site and add **Cultus Lake Park Board** as a payee.
 - You will need your Roll Number (found at the top of your bill), as this number is used to determine your Account Number.
 - Your **Account Number** is the last seven (7) digits of your Roll Number.
- For Example: If your Roll Number is “733 0XXXX.###” – your Account Number is “XXXX###”*

DEMOLITION AND CONSTRUCTION

Cultus Lake Park is comprised of two (2) overlapping jurisdictions, where both Cultus Lake Park (CLP) and the Fraser Valley Regional District (FVRD) are responsible for planning and building within the park. The permit process for any construction at the park requires review by both CLP and FVRD.

The Building and Demolition permit and review process ensures that all buildings and related construction activities comply with the safety, health and building requirements of the local government, Province of British Columbia, and associated regulatory bodies.

Before submitting a building permit application, you will need to contact the park office to initiate the process at reception@cultuslake.bc.ca. CLP will complete the initial application review prior to FVRD beginning their process. Demolition permits, building permits, and building inspections are provided separately by the FVRD. Residential leaseholders may purchase Contractor Parking Permits which would allow access to 10 permits for \$1,000, permitting parking in residential overflow areas.

HIGHWAY CLOSURE PROCEDURES

As per the Parking and Traffic Regulations Bylaw No. 1190, 2021 and all amendments, “No person will partially or fully block a Highway without an approved Highway Closure Permit, or if a permit is denied. Fines are set out in Cultus Lake Park Bylaw Notice Enforcement Bylaw No. 1140, 2019 and all amendments.”

- Highway Closure Applications will not be approved for a Monday due to Waste and Recycling removal; and
- will not be approved to begin prior to 9:00 am.
- Applicants must complete and return the Highway Closure Application at least seven (7) days prior to the requested highway closure date:

Forms can be returned to the Park Office or via email at reception@cultuslake.bc.ca with the \$50 fee payable in person by, cash, debit, or credit card or by credit card over the phone at 604-858-3334.

- Once the application form and payment are received, it will be reviewed by staff and then the applicant will be informed if the application is approved or denied.
- If approved, the applicant must pick up the permit to be posted.
 - The permittee must post the permit 72 hours prior to the closure date at the location directed by the Park. This location will depend on the site of the highway closure.
 - Depending on the location of the closure the applicant may be required to inform any residents who will be inconvenienced by the closure 72 hours prior to the date.
 - Park staff will prepare notices, but it will be up to the applicant to deliver notices to effected residents. If you have any questions, please contact reception at 604-858-3334 or at reception@cultuslake.bc.ca.

RESIDENTIAL ELECTRONIC PARKING PERMIT PORTAL

All vehicles on Cultus Lake Park property are required to register a valid parking permit through [Home \(gtechna.net\)](http://Home.gtechna.net), as per the Parking and Traffic Regulations Bylaw No. 1190, 2021: Parking-and-Traffic-Regulations-Bylaw-No.-1190-2021.pdf (cultuslake.bc.ca).

The office will create an account for you with a username and password. (*Please go in and change your password within 24 hours).

Each lease lot is issued four (4) FREE permits, with an option to purchase an additional two (2) permits at \$100 each year at a prorated cost to be processed through the office, valid May 1 - April 30 for each year.

- There is also an option to purchase two (2) daily permits at a cost of \$6/each, which expire at midnight of the same day and can be purchased through the parking portal.

Please note these permits are NOT VALID in lots A, B, C, D or the Plaza.

HOW TO USE PARKING PORTAL

1) GO TO [Home \(gtechna.net\)](http://gtechna.net)

2) SIGN INTO ACCOUNT

3) ADD VEHICLES AND PERMITS

A two-step process: 1) Add Vehicles into the library. 2) Permit active Vehicles (the portal allows you to change them immediately for guests coming to your property) 3) Submit to Save.

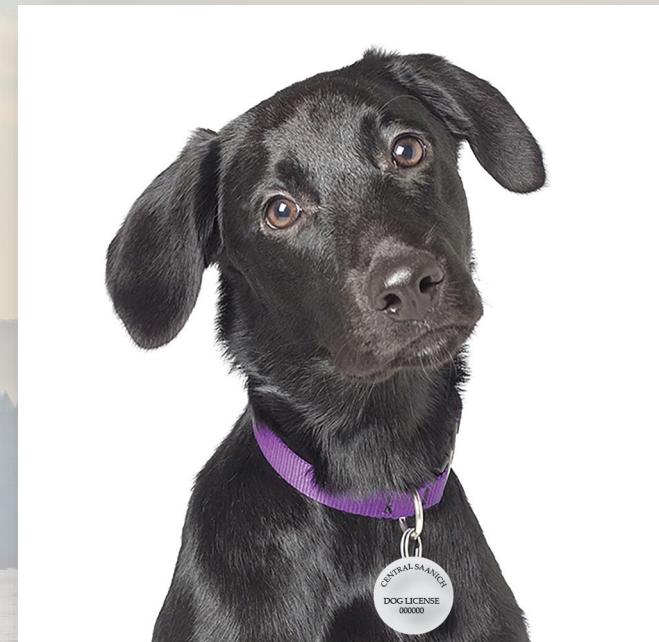
DOG LICENCES

As per the Animal Control and Regulations Bylaw No. 1142, 2019, [Animal Control and Regulations Bylaw No. 1142, 2019](#) dogs over the age of four (4) months are required to have a dog licence.

Tags can be purchased at the **Cultus Lake Park Office**. Office hours are Monday to Friday, from 8:30 am to 4:30 pm (except for statutory holidays).

LICENCE FEES:

- Neutered male or spayed female dog – \$20
- Intact female dog – \$70
- Intact male dog – \$70



TREE MAINTENANCE APPLICATION

All leaseholders must make an application to have any work completed on trees within Park boundaries, such as tree removal, pruning, canopy lifting on Park or leasehold property for indigenous or non-indigenous tree maintenance.
